- Adverse childhood experiences/trauma informed care;
- Uses of data to advance health equity; and
- Universal access or accessibility in addition to ADA.

Advanced Health would like to support your team in completing these trainings. For your convenience, we have several free online trainings available for you and your staff (see attached list or go to www.advancedhealth.com/provider/provider-trainings). We are also committed to bringing experts to our region. When possible, we will offer Continuing Medical Education (CME) and other continuing education credits to attendees.

We will be working with your Human Resources staff or other office staff to develop a tracking and reporting process for completed trainings. We need this documentation for compliance purposes. If you or your staff have already completed trainings in any of the above training areas in 2019, you can submit proof of those trainings.
