

## 2019 Oregon CCO Quality Incentive Measures

- 1. Adolescent well-care visits (*claims data*) members ages 12-21 who have an annual well-care visit during the measurement year.
- 2. Assessments within 60 days for children in DHS custody\* (*claims data*) —within 60 days of entering DHS custody, children less than 1 year old receive physical health assessment; children ages 1 3 receive physical and dental health assessment; children age 4 and older receive physical, dental, and mental health assessment.
- 3. **CAHPS composite: access to care** *(member survey)*—members who thought they received appointments and care, both routine and urgent, when they needed them.
- 4. **Childhood immunization status\*** (*ALERT IIS data*) —members turning 2 who have received all vaccinations recommended by the American Pediatrics Association Well Child Schedule.
- 5. **Cigarette smoking prevalence** *(EHR data)* —percentage of members age 12 and up who smoke tobacco cigarettes.
- 6. **Colorectal cancer screening** *(claims and chart review data)* —members ages 50 to 75 with up-to-date colorectal cancer screenings (FOBT, FIT, colonoscopy).
- 7. **Controlling high blood pressure** (*EHR data*) —members ages 18 to 85 with a diagnosis of essential hypertension with blood pressure <140 mmHg systolic and <90mmHg diastolic at last office visit during the measurement year.
- 8. **Dental sealants on permanent molars for children** *(claims data)* —children ages 6 14 who received a sealant on a permanent molar tooth during the measurement year.
- 9. **Depression screening and follow-up plan** (*EHR data*) —members age 12 and up who were screened for depression or had a follow up plan for a positive screen during an office visit in the measurement year; excluding patients with active depression or bipolar disorder diagnoses
- 10. **Developmental screening in the first 36 months of life\*** (*claims data*) —children turning 1, 2, or 3 who received developmental screening as recommended by Bright Futures guidelines.
- 11. **Diabetes: HbA1c poor control** (*EHR data*) —members ages 18 75 with diabetes that is poorly controlled; no HbA1c test or the most recent HbA1c level is over 9% (lower is better for this measure).
- 12. **Disparity measure: emergency department utilization among members with mental illness** *(claims data)* —number of ED visits per 1,000 member months among members with a mental illness diagnosis (lower is better for this measure).
- 13. **Drug and alcohol Screening (SBIRT)** *(EHR data)*—Percentage of patients ages 12 years and older who have had one or more screening, brief intervention, and referral to treatment services in the measurement year.
- 14. Effective contraceptive use among women at risk of unintended pregnancy (*claims data*) —female members age 15 to 50 using effective contraception (sterilization, IUD, implant, injection, pill, patch, ring, diaphragm).
- 15. Emergency department utilization (*claims data*) —number of ED visits per 1,000 member months (lower is better for this measure).
- 16. **Oral evaluation for adults with diabetes** *(claims data)*—percentage of adult members identified as having diabetes who received a comprehensive, periodic or periodontal oral evaluation.
- 17. **Patient-Centered Primary Care Home (PCPCH) enrollment** —members assigned to a PCPCH recognized practice, weighted by tier.
- 18. **Timeliness of postpartum care\*** *(claims and chart review data)*—percentage of women giving birth who had a postpartum visit on or between 21 and 56 days after delivery.
- *19.* Weight assessment and counseling (*EHR data*) —children ages 3-17 who have documentation of BMI calculation and counseling for nutrition and physical activity during an office visit.
