

Assessment for Children in DHS Custody

2019

Measure description: Percentage of children ages 4+ who received a mental, physical, and dental health assessment within 60 days of the state notifying CCOs that the children were placed into custody with the Department of Human Services (foster care). Physical and dental health assessments are required for children under age 4, but not mental health assessments.

Purpose: Children who have been placed in foster care should have their mental and physical health checked so that an appropriate care plan can be developed. Mental and physical health assessments are a requirement for the foster program because of their importance to improving the health and well-being of a child in a trying situation

Measure Specifications

Data: Claims data (MMIS/DSSURS)

Improvement Target: TBD

Benchmark Target: 90.0%

Denominator: Identified children/adolescents 0 – 17 years of age as of the first date of DHS/OHA notification and remained in custody for at least 60 days. Only children/adolescents that DHS/OHA notified CCOs about will be included in the denominator.

Numerator: Depending on the age at CCO notification date, members in the denominator are required to receive a physical health assessment, a dental health assessment, and a mental health assessment within 60 days of the notification date, or within 30 days prior to the notification date.

Continuous Enrollment: 60 days after the date of CCO notification
