Tribes, 34 organizations, receive \$23 million to support home repairs:

Oregon Health Authority (OHA) has awarded \$23 million to repair and rehabilitate homes of low-income residents to eliminate risks to residents' health to the Nine Federally Recognized Tribes of Oregon and 34 local organizations. The funds are from the Healthy Homes Grant Program (HHGP), established to improve health by rehabilitating living environments in Oregon.

They have their nursing strike that started on Friday January 10th and that that is still in force. Information directly from Providence:

- 1. Hospitals are open and ready to care for patients. Limited capacity at this time is Providence Saint Vincent (Portland area).
- 2. They have secured the services of highly qualified, experienced replacement workers who will be working alongside our existing caregivers.
- 3. If you have a Critical, emergency need, and you are near a Providence hospital, be assured we will take care of you. May experience wait times that are longer than normal.
- 4. If a patient needs to be deferred or reschedule procedures or appointments, Providence will contact patients directly.
- 5. Clinic appointments located in or near a Providence hospital, may need to check-in at a designated entrance.

Young Adults with Special Health Care Needs (YSHCN)

New Oregon Health Plan program: Young Adults with Special Health Care Needs (YSHCN) will launch January 1, 2025, for eligible young adults aged 19 and 20 years old.

Benefits: Enrolled members will qualify for enhanced vision and dental benefits and Early and Periodic Screening, Diagnostic and Treatment (EPSDT) (<u>Link</u>) and may have access to Health-Related Social Needs (HRSN) benefits (<u>Link</u>).

Eligibility: YSHCN will offer more benefits to young adults ages 19 and 20 with a family income up to 205% of the Federal Poverty Level (Link) who also have special health care needs Learn more about YSHCN here (Link)

Oregon records highest pertussis:

As Oregon closes out 2024 with a record-breaking number of pertussis (whooping cough) cases, health officials remind everyone that vaccination is the best way to prevent pertussis and, particularly, severe illness among babies. If you do not know when or if you were last vaccinated against pertussis, we recommend all people over age 10 receive a dose of Tdap.

Infants cannot be vaccinated against pertussis until they are two months old, <u>pregnant people</u> are recommended to get the Tdap vaccine at 27–36 weeks' gestation. Additionally, when pertussis strikes a household in which an infant or pregnant person lives, OHA recommends <u>all members of the household</u> receive a course of antibiotics effective against Bordetella pertussis—typically, a five-day course of azithromycin. Radon Action Month in January: Colorless, odorless gas is the second leading cause of lung cancer behind smoking.

The Radon Awareness Program monitors which areas of the state have the potential for high radon levels and identifies regions where educational outreach efforts need to be focused. The program is offering a free radon test kit to residents whose homes are in ZIP codes with fewer than 20 radon test results. Residents can learn more about the free radon test kit program and how to apply at www.healthoregon.org/radon. Free test kits are available while supplies last.

Home testing kits can be purchased at hardware or home improvement stores, with prices ranging from \$20 to \$30. You can also order a radon test kit online from the <u>American Lung Association</u>. If you would prefer to have a professional test your home, contact a <u>certified radon measurement company</u>.

Governor Kotek's Budget 2025-2027

OHA Director Sejal Hathi, M.D.:

Dr. Hathi directed leaders within OHA to review the concerns local partners raised and develop action plans to address them. The new report describes 16 separate efforts that state officials are pursuing to respond to the challenges they heard, including:

- Reducing administrative burdens on mental health and substance use programs.
- Supporting traditional health workers to bill Medicaid for services.
- Preventing health care facility closures in rural communities.
